CECMC Inspection Report Summary

On 11/06/2024 at approximately 13:15 hours, Compliance Inspector Dusty Popejoy conducted a follow up inspection at LARAMIE ENERGY LLC CC/604-41-32 Pad at Location ID #335902 in Garfield County, Colorado.

Please refer to inspection 713400232 conducted on 08/02/2024, previous corrective action has been completed.

This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area.

During the inspection, the following compliance issues were observed:

1. Stormwater - Improperly stored chemicals next to wellheads with a CA date of 11/13/2024
2. Equipment - Open ended piping/wildlife hazard/ available for entry by wildlife with a CA date of 11/17/2024
3. Housekeeping - Wildlife protection for containment needs maintenance/screen is damaged with a CA date of 11/17/2024

A follow-up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
