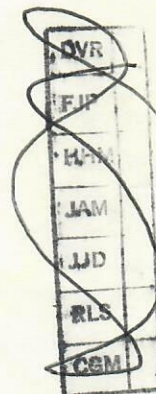

Section 22: The South 35 acres of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ and the South 35 acres of SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ (Expect a tract of land containing 5 acres more or less described as follows: Commencing at the SE corner of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Section 22: thence North, 580.00 ft., along the East line of the SW $\frac{1}{2}$ of the NE $\frac{1}{4}$ of said Section 22, to the true point of beginning; thence West, 164.00 ft.; Thence North 82.00 ft.; thence West, 251.00 ft.; thence North; 493 ft., more or less, to the North line of the South 35 acres of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Section 22; thence Easterly, 415 ft., along the North line of the South 35 acres of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Section 22, to a point on the East line of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Section 22; thence South, 575 ft., along the East line of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Section 22, to the true point of Beginning) and containing 65 acres, more or less.
