A site investigation was conducted pursuant to ECMC Rule 911 at the LATHAM T4N-R65W-S2 L01 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel excavation, beneath the ground oil tank, and at the separator. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

None of the collected samples were analyzed for Table 915-1 Metals. Consequently, all samples will be re-collected for Table 915-1 Metals as per Supplemental Form 27 # 403622997 COA.

A proposed SSI map is attached to this Form 27. Based on the ECMC Table 915-1 exceedances identified during decommissioning, and the COA on Supplemental Form 27 # 403622997, Noble proposes to limit future soil sampling to pH and metals. Concurrently with the SSI, additional background samples will be collected to determine if pH is attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27. Based on the ECMC Table 915-1 exceedances identified during decommissioning, and the COA on Supplemental Form 27 # 403622997, Noble proposes to limit future soil sampling to pH and metals.

Concurrently with the SSI, additional background samples will be collected to determine if pH is attributed to native soil conditions at the site.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the SSI will be submitted on a subsequent Form 27.
