OPERATOR COMMENTS:

The spill was identified during an ECMC Reclamation Inspection Report #713601556. The small oil-stained areas by the compressor engine skids and fuel tank was determined to be less than 1 barrel of oil inside of containment. Stained soil will be excavated and removed.

Citation is submitting this Form 19 Initial in response to the ECMC Reclamation Inspection Report #713601556 COAs: " Control and contain spills/releases and clean up per Rule 912.a."

Further, the ECMC communicated in email correspondence (10/29/2024) to assess 6 sites for reclamation needs and potential for Form 19 spill reporting. It was determined this location would require reporting due to application of Rule 912.b.(1).G: A suspected or actual Spill or Release of any volume where the volume cannot be immediately determined, including a spill or release of any volume that daylights from the subsurface.

Citation will submit a Form 19 supplemental 10-day report including the following supportive documentation: notifications (local government, surface owner); root cause & preventative measures; known information about the spill; initial mitigation; figure displaying proposed sample locations. Citation will assess the nature of the spill by delineating the horizontal and vertical extent of impacts through excavation, soil screening with a PID and collection of confirmation soil samples. Confirmation samples will be collected to adequately demonstrate removal of impacts and analyzed for Table 915-1 constituents. Citation will submit a Form 19 supplemental 90-day report requesting closure including the following supportive documentation: figure displaying impacted area/depth and sample locations; summary of field observations, soil screening and laboratory analytical results; waste disposal documentation.
