The source will be removed through excavation. Grab soil samples will be collected and submitted to a certified laboratory for analysis of Table 915-1 metals and organic compounds, TPH C6-36, EC, SAR, pH, and boron.

The estimated timeframe to achieve a no further action will be January 31, 2027.
