A supplemental site investigation (SSI) will be completed to collect additional background samples to determine if arsenic, pH, and barium are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

Concurrently with the flowline direction change sampling, background samples will be collected for analysis of metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. The results of the SSI will be submitted on a subsequent Form 27. The flowline is currently planned for future removal, at which time soil sampling and screening samples will be taken along the flowline at any points of material change and/or hammer unions, and directional changes. Pursuant to the flowline removal, all laboratory analytical samples will be analyzed for full ECMC Table 915-1 contaminants of concern. Additional SSI activities will be proposed (as applicable) on a future Form 27 if further investigation is required.

The implementation schedule has been changed due to the decommissioning of the WELLS RANCH AA35-69-1HNB flowline and necessity for supplemental site investigation activities adjacent to the flowline. The proposed site investigation will be completed following the approval of this form, landowner negotiations, and crew availability.

OPERATOR COMMENT

This Form 27 is being submitted to include the decommissioning results at the former Wells Ranch AA35-69-1HNB flowline location. A proposal to delineate the pH and selenium exceedances identified during decommissioning (soil samples FL01R-S@4', FL01R-W@4', GL01R-01@5', and GL01R-W@4') is presented in the Site Investigation Report section of this Form 27.

The flowline is currently planned for future removal, at which time soil sampling and screening samples will be taken along the flowline at any points of material change and/or hammer unions, and directional changes. Background samples will also be collected during flowline decommissioning. Pursuant to the flowline removal, all laboratory analytical samples will be analyzed for full ECMC Table 915-1 contaminants of concern. Additional SSI activities will be proposed (as applicable) on a future Form 27 if further investigation is required. Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
