On 11/21/2024, the potential presence of impacted material(s) was identified via hydrocarbon odor during decommissioning activities at the Frico 21-14, wellhead, samples: WH01, and WH01-E. Both the base and sidewall sample are from the same wellhead excavation. The volume of potentially impacted material(s) is not currently known. Out of an abundance of caution, the operator is submitting notification within 24 hours of the discovery of the potential presence of impacted material(s) soil. Initial soil sampling is underway to determine whether any constituents are present at levels in excess of Table 915-1 standards. Groundwater was not encountered during decommissioning activities. This location is within the following High Priority Habitats: Bald Eagle Active Roost Site and Mule Deer Severe Winter Range. Also, this site is located within 300 feet of surface waters of the state.
