Operator Comment: On 11/21/24, TEP responded to a small dump line leak at the Clough RMV 25-20 well pad. The well was shut in for the night, and crews returned this morning (11/22/24) to repair the leak. Production personnel discovered that a union joint was not fully tightened and had leaked approximately 3 gallons of produced water. Repairs were completed by approximately 8:30 a.m. on 11/22/24. Impacted soils were also cleaned up / removed, and the area was repaired with clean gravel (see attached). This was not a reportable incident.

The Field Inspection Report states that the "location is approximately 68 yards from a drainage that contributes to the Colorado River." To clarify, the location may be 68 yards from a dry drainage that is tributary to the Colorado River, however, the actual distance from the location to the Colorado River is approximately 4,300 feet (1,430 yards).
