A site investigation was conducted pursuant to ECMC Rule 911 at the DANE FRICO REI T3N-R65W-S10 L01 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel excavation, beneath the ground oil tank, and at the risers for the dumpline of any separators. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

A supplemental site investigation (SSI) will be conducted to vertically and horizontally delineate the inorganic exceedances observed at AST01@0.5', FS01@5', SEP01-DL@3', SEP01-FL@3' during decommissioning. A proposed SSI map is attached to this form 27. Based on the ECMC Table 915-1 exceedances identified during decommissioning, Noble proposes to limit future soil sampling to pH and arsenic. Concurrently, background samples will be collected to determine if pH and arsenic are attributed to native soil conditions at the site. The SSI will be completed in accordance with the attached proposed site investigation map, and proposed sampling plan outline in the Site Investigation Report section of this Form 27.
