INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the ULRICH 23-26 wellhead cut and cap. The wellhead will be cut and capped per ECMC rules. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. The flowline was previously abandoned on 10/25/2018, and the ECMC was notified on Form 44 Document number 403216804.

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample will be collected at the wellhead excavation, and soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

OPERATOR COMMENT

This Supplemental Form 27 is being submitted as an Annual Timeline Update for the ULRICH 23-26 wellhead. Per recent correspondence with the ECMC, Noble is proposing an annual timeline reporting frequency until decommissioning activities occur. The Q3 2024 Timeline Update, with the original request for annual reporting frequency, submitted on 8/28/2024 under Form 27 Document Number 403851377, was approved with a COA to address the implementation schedule changes. The implementation schedule is filled in on this Form 27 per recent agreement with ECMC to allow for annual reporting until decommissioning occurs at this facility. Supplemental Form 27s will be prepared on an annual basis until decommissioning of the site infrastructure is complete. Following decommissioning activities, a Supplemental Form 27 will be prepared within 90 days of field activities unless a reportable release is discovered.
