OPERATOR COMMENT

Based on limited information, the approach is to determine if impacts exist adjacent to the tank. Based on the referenced inspection reports and limited aerial imaging the only information refers to the pit next to the tank. Based on the history of the area and other similar locations the pit is estimated to be in near proximity to the tank and small in size. Two drilling locations have been proposed based on the information in the historic inspection reports and limited locations for the tank to have existed on-site. Estimated depth of the pit based on operator knowledge of similar pit of this age being 10-15' and a boring assessment depth of 20' unless impacts are identified.
