On Monday, 11/25/2024, Inspector Kirby Burchett, conducted a routine field inspection at Caerus Piceance – QB Energy on the Figure Four Unit 8008D A16 498 well, Location #311850, in Rio Blanco County, Colorado.

This location is within or close proximity to a Parks & Wildlife (CPW) District and Black Bear area with High Priority, NSO, and Density Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

Well is on the same location as the Figure Four Unit 8003D A16 498 well, Location #311849 with a shared tank battery.

While there during normal operations the following compliance issue was observed:

1. Gas meter calibration not up to date.
