INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Decommissioning activities were completed at the Leahy 43-9D O SA production facility on September 15-16, 2022. Groundwater was not encountered during excavation activities. Visual inspection and field screening of soils at one separator, one meter house, one emissions control device (ECD), one produced water vessel (PWV), seven dump line locations, and one aboveground storage tanks (AST) was conducted following removal activities and soil samples (SEP-B01@4', SEP-B02@2', PW-S01@2.5', PW-B01@5', and AST-B02@3") were submitted for laboratory analysis to determine if a release occurred. Laboratory analytical results for PW-S01@2.5' indicated that the 1,2,4-trimethylbenzene, arsenic, barium, and selenium concentrations exceeded the applicable ECMC Table 915-1 standards and background limits. As such, a Form 19-Initial/Supplemental Spill/Release Report (ECMC Document No.403169176) was submitted on September 19, 2022, and the ECMC issued Spill/Release Point ID 482942. The remaining analytical results for the soil samples collected were in compliance with ECMC Table 915-1 standards and/or background limits. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample location and field screening data is presented in Table 1. The facility soil sample and field screening locations are illustrated on Figures 2-4. The laboratory analytical reports are provided as Attachment A. The field notes and photographic log are provided as Attachment B.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

From September 15 through October 26, 2022, excavation activities were conducted to address remaining soil impacts at the former produced water vault location and four (4) confirmation soil samples were collected from the sidewalls of the final excavation extent, at a depth of approximately 2.5 feet below ground surface (bgs). Based on waste characterization results (PW-S01@2.5'), the confirmation soil samples were submitted for laboratory analysis of 1,2,4-trimethylbenzene, arsenic, barium, and selenium using ECMC approved methods. Analytical results indicated that constituent concentrations in the soil sample collected from the final excavation extent were in compliance with the applicable ECMC Table 915-1 standards and/or within background limits. Soil analytical results are summarized in Tables 2-5.

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

On September 15 and 16, 2022, visual inspections and field screening of soils was conducted at three sidewalls of the PWV excavation, one former meter house, one former ECD, seven dump line potholes, and one former AST. Based on the inspection and screening results, hydrocarbon-impacted soils were not observed at the soil screening locations. As a result, no soil samples were submitted for laboratory analysis from these areas in accordance with the ECMC Operator Guidance for Oil & Gas Facility Closure document.

Background soil samples were collected from three locations near the former PWV location. Additionally, background soil samples collected from native material near the Leahy 43-9D wellhead (located approx. 450 feet south) from similar depths, soil type, and land use were applied. The background soil samples were submitted for laboratory analysis of the Soil Suitability for Reclamation Parameters and Table 915-1 Metals in Soils using standard methods appropriate for detecting the target analytes in Table 915-1. Analytical results for the background soil samples are presented in Tables 3 and 5. Background sample locations are illustrated in Figures 3-4.

Between September 15 and October 26, 2022, approximately 70 cubic yards of impacted soil was excavated and transported to Front Range Landfill in Erie, Colorado, and approximately 80 cubic yards of impacted soil was excavated and transported to Buffalo Ridge Landfill in Keenesburg, Colorado for disposal. The excavation area will be backfilled and contoured to match pre-existing conditions.

REMEDICATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Laboratory data indicate that impacted soils in the excavation area have been remediated to be in compliance with the ECMC Table 915-1 standards and/or within background limits. Groundwater was not encountered during decommissioning activities. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.
