A site investigation will be conducted pursuant to COGCC rule 911 at the Schell 41, 42-6D (463216) oil and gas location pertaining to the decommission of production facilities and decommission of all on-location flowlines. See site map exhibit for details.

Twelve grab soil samples were collected from the decommissioned tank battery and two composite soil sample was collected from the stockpiled overburden. All soil samples were submitted to a certified laboratory for analysis of Table 915-1 metals and organic compounds, TPH C6-36, EC, SAR, pH, and boron.

The source will be removed through mechanical excavation. Grab confirmation soil samples will be collected and submitted to a certified laboratory for analysis of Table 915-1 metals and organic compounds, TPH C6-36, EC, SAR, pH, and boron to determine the lateral and vertical extent of impacts. Additional background samples will be collected from homogenous soil horizons and/or corresponding excavation sample depths.

Subsequent to source removal, a groundwater site assessment will be scheduled to determine the extent of impacted groundwater.
