This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area.

During the inspection, the following compliance issues were observed:

- Housekeeping - Wildlife protection for chemical containment needs maintenance/screen is damaged and open to wildlife, also appears to have dead wildlife in containment with a CA date 11/29/2024
- Tanks and Berms - Multiple holes and tears in secondary containment liner/liner needs maintenance also the liner is deteriorating and lacks integrity with a CA date 12/13/2024

A follow-up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
