Immediately after spill, containment was secured and soil was picked up to stop continued spread. Since then, 4 excavation events with soil sampling have occurred under the initial filed from 19.

#### PROPOSED SAMPLING PLAN

To date, a total of 20 samples have been taken, over (4) different sampling events. Each sampling event occurred with an excavation attempt to clear and remove contaminated soils from the spill. Each event showed decreased contamination, but still with elevated numbers above ECMC table 915 standards. An additional excavation and soil sampling event is planned to get final contaminations removed from the location. Due to winter weather conditions, the location is currently intermittently covered with snow and unaccusable. The excavation and soil sampling event is planned for early spring of 2025, once the location is accessible.

The excavation and soil sampling event is planned for early spring of 2025, once the location is accessible.

Next remediation event will be conducted with a backhoe and excavation team focused on remaining are showing contamination. Remaining area is localized to a very small extent and will be excavation deeper to gain access to clean dirt.

Operator plans to make a (4th) excavation event, paired with updated soil sampling to address contaminated soil. Each of the previous (3) soil samples have shown decreases in the contamination and localized the effected area to a much smaller size. The updated excavation event will be done when the location is accessible post current winter conditions and able to get machinery safely into location without damaging other unaffected surface locations. The attached document shows the updated remediation plan for the remainder of the project.
