Grab confirmation soil samples were collected from the partially buried vessel(s) excavation. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the pH exceedances observed during decommissioning. A proposed SSI map is attached to this Form 27. Based on the ECMC Table 915-1 exceedances identified during decommissioning, Noble proposes to limit future soil sampling to arsenic, barium and pH. Concurrently with the SSI, additional background samples will be collected to determine if pH, arsenic and barium are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.
