	<p>It was observed in this inspection that reclamation appears to be progressing towards a perennial vegetation standard of 80%, however it is noted that species in the disturbance area (alfalfa, sweet clover) are not reflective of the reference area (smooth brome). In addition, tracks along the access road remain evident; indicating compaction alleviation either has not been performed, or compaction issues remain and require addressing pursuant to Rule 1003.c. Reclamation is in process. CO List B Noxious weeds (houndstongue, cheatgrass, bull thistle and Canada thistle) were observed throughout the Location.</p>
