The Residential Well (DWR Receipt 0542106, Permit 265959-) approx. 535-ft to the NW is the nearest permitted water well. This well was constructed to 415-ft, static water level recorded at 140-ft. Residential Well (DWR Receipt 0531524, Permit 261212-) is approx. 805-ft to the SE. This well was constructed to 416-ft, static water level recorded at 95-ft. Residential Well (DWR Receipt 3667070, Permit 296636-) is approx. 1050-ft to the NE. This well was constructed to 380-ft, static water level recorded at 120-ft.  
Groundwater less than 20 ft is not expected at the disturbance location.

A site investigation will be conducted pursuant to COGCC rule 911 at the AMOCO-61S65W 17N2S2SE (320283) oil and gas location pertaining to the cut/cap of the AMOCO 44-17 (05-001-08859), decommission of production facilities, decommission of the AMOCO 44-17 (00108859FL) wellhead line, and decommission of all on-location flowlines. See site map exhibit for details.

### PROPOSED SAMPLING PLAN

#### Proposed Soil Sampling

Grab confirmation soil samples will be collected from beneath the above ground oil tank, water vault, separator, wellhead, and flowline start/end points. Potholes will be dug every 250 feet along the FL path. These observation points will be photographed and field screened. Additional soil samples will be collected when FL repairs are observed, changes in flow direction, or when there is a change in the FL material type. A grab confirmation soil sample will be collected from the center of the produced water vault footprint, or areas of observed impact based on visual and olfactory observation. A minimum of four sidewalls and the base will be field screened. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
