Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Fifteen background soil samples were collected from an area not impacted by oil and gas development and at similar depths (0.5', 4', 5') and lithologies as confirmation soil samples collected at the location and analyzed for Table 915 metals and inorganic SSR constituents. Background soil sample analytical results were reported with elevated levels of arsenic, barium, cadmium, lead, and selenium and SAR.

Elevated inorganics and metals were observed in at the former Grant Arens tank battery. Soil will be resampled and analyzed for Table 915-1 SSR constituents at the AST02@0.5' PWV01-B@5' sample locations, Table 915-1 metals at the PWV01-B@5' and PWV01-E@4' sample locations, and lead at the PWV01-E@4' at the same depth where the initial elevated concentrations were observed. Noble will request an NFA be granted if the reanalyzed samples are within the Table 915-1 concentration range.

Alternatively, if the sample results do not comply with their respective Table 915-1 concentration standards and cannot be attributed to native soil conditions via background soil characterization a minimum of five additional samples will be collected to delineate the magnitude and extent of residual constituents in exceedance. Following completion of additional delineation Noble will submit a detailed reclamation plan and will request NFA designation be granted.
