Residential Well (DWR Receipt 9065733, Permit 83733-) is approx 165-ft to the S. This well was constructed to 556-ft, static water level recorded at 200-ft. Residential Well (DWR Receipt 9061785, Permit 13916-) is approx 450-ft SW. This well was constructed to 83-ft, static water level recorded at 42-ft.

Groundwater less than 20 ft is not expected at the disturbance location.

INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation will be conducted pursuant to COGCC rule 911 at the MELBON RANCH 62N65W 17 NESE 43-17 (458018) oil and gas location pertaining to abandonment of the off-location Melbon Ranch 43-17 (05-123-21729), Melbon Ranch 33-17 (05-123-34583), Melbon Ranch 6-4-17 (05-123-34578), Melbon Ranch 8-8-17 (05-123-34580), and Melbon Ranch 8-6-17 (05-123-34588) wellhead lines. See site map exhibit for details.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Grab confirmation soil samples will be collected from beneath the flowline start/end points. Potholes will be dug every 250 feet along the flowline path. These observation points will be photographed and field screened. Additional soil samples will be collected when flowline repairs are observed, changes in flow direction, or when there is a change in the flowline material type. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
