Any variance request submitted to any ECMC Unit prior to January 15, 2021 must be resubmitted in accordance with Rules 502 and 503.a, if the applicant wishes to have its variance request considered. Operators request for delayed interim reclamation submitted on 12/15/2020 should have been resubmitted.Interim reclamation is past due. Original CA date of 9/1/2021 remains applicable.Corrective Action Reclamation needs to be conducted in areas not needed for production operations in accordance with 1003 reclamation rules.
