Follow up inspection in response to compliance issues observed during Insp. #715500524 on 8/6/24. Tank battery sign has been installed and labels on 1 tank only. The following Corrective Actions are still unresolved and original due dates remain:

1. Tank not labeled.
2. Sinkhole near wellhead.
