INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations were completed at the Kerr-McGee 23-13 wellhead on September 20, 2024. Groundwater was not encountered during excavation activities. Visual inspection and field screening of soils around the wellhead and associated pumping equipment was conducted following cut and cap operations, and a soil sample [B01(23-13)@6"] was submitted for analysis of full list Table 915-1 constituents, to determine if a release occurred. Final laboratory analytical results are pending. The flowline was previously removed on June 14 and June 15, 2023, under Form 27 Document No. 403327270, Remediation No. 27992. The soil sample locations are depicted on Figure 1. The PID readings are summarized in Table 1.

Assessment activities are ongoing, and details will be provided in a subsequent Form 27 Supplemental report.

On September 20, 2024, a soil sample was collected from the base of the cut and cap excavation [B01(23-13)@6"]. The soil sample was submitted for full list Table 915-1 constituents, using ECMC-approved methods. Final laboratory analytical results are pending. The PID readings are summarized in Table 1.

Additional Investigative Actions

☐ Additional alternative investigative actions described in attached Site Investigation Plan (summary):

On September 20, 2024, visual inspections and field screening of soil were conducted at four sidewall locations within the cut and cap excavation area and four locations at the ground surface adjacent to the excavation. Based on the inspection and screening results, hydrocarbon-impacted soils were not observed at the soil screening locations. As a result, no soil samples were submitted for laboratory analysis from these areas in accordance with the ECMC Operator Guidance. A photographic log is attached.

On October 2, 2024, a soil gas survey was conducted at five soil vapor points installed adjacent to the former wellhead location following cut and cap operations. GEM 5000 field readings were all non-detect for methane at all soil vapor points. The soil vapor point locations are illustrated on Figure 1. The soil vapor field form is included as an attachment.
