Comments: A bradenhead test was conducted on the Adamic #1-20 well on Dec. 4, 2024. No pressure communication was observed between the bradenhead or production casing. The production casing valve immediately dropped from 3 psig to 0 psig once its valve was opened and stayed at 0 psig for the remaining 30 minutes of the test. Tubing pressure also remained at 0 psig.
