On Wednesday, 12/04/2024, Inspector Kirby Burchett, conducted a routine field inspection at Beeman Oil & Gas Inc. on the Welker 6-92 1-2H11 well, Location #438580, in Moffat County, Colorado.

This location is within or close proximity to a Parks & Wildlife (CPW) District with High Priority, NSO, Density and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

While there during normal operations the following compliance issues were observed:

1. Unmarked and illegible container labels.
2. Equipment open to wildlife.
3. No visible display of gas meter calibration.
4. Tank battery sign missing required information.
5. Random debris.
6. Oily waste and staining.
7. Relief vent riser missing cap.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with ECMC rules.
