<p>ECMC Inspection Report Summary</p> <p>WEATHER CONDITIONS: sunny, dry ground.</p> <p>On Thursday, December 12, 2024 at approximately 1215, I, Inspector Brittani Santistevan, conducted an on-site inspection at FEDERAL 11-10, ARISTOCRAT ANGUS FEDERAL 2-10 (Crestone Peak Resources), at location ID: 332731 in WELD COUNTY, Colorado. While there, I observed a shut-in facility.</p> <p>During this inspection the following possible compliance issues were observed:</p> <p>1. It appears to be disconnected equipment inside both wellhead fencings and unused risers (what appears to be from removed tank battery) LOTO risers or remove and reconnect or remove equipment to comply with Rule 606. (Corrective Action Date: January 12, 2025) See attached photo #3, 6, 8.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
