Petrox is in the process of P&A the FGU 16U-1 and completely reclaiming the entire location. Petrox has been working with the surface use agency, the San Juan National Forest (SJNF), to determine the extent of the access road they want reclaimed. Currently the SJNF is closed from December 1st to May 1st as outlined in the Fosset Gulch Unit Surface Use Plan of Operations with the SJNF so work can not be started until after May 1st. Petrox will be submitting P&A protocols to the ECMC as soon as the final reclamation plans are approved by the SJNF for the pad and access road. Work is estimated to be completed by the end of May 2025.
