Interim reclamation is not progressing at the location or along the flowline disturbance area. It appears drill seeding was performed along the flowline but not at the location. The disturbed soils need to be stabilized until vegetation establishes with the use of BMP's (straw mulch, hydromulch, ect.). The use of mulch could be beneficial for vegetation establishment. All soil decompaction, reclamation, and stabilization will need to be completed before the upcoming growing season.
