Comment Interim reclamation is not progressing at the location or along the flowline disturbance area. It appears recent work has been performed at the well and soils have been disturbed and compacted. The disturbed soils need to be reseeded and stabilized until vegetation establishes with the use of BMP's (straw mulch, hydromulch, ect.). The use of mulch could be beneficial for vegetation establishment. All soil decompaction, reclamation, and stabilization will need to be completed before the upcoming growing season.
