**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the GIBSON 11-9 wellhead cut and cap. The wellhead will be cut and capped per ECMC rules.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the GIBSON 11-9 flowline removal. Approximately 1633' of flowline will be removed. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

**PROPOSED SAMPLING PLAN****Proposed Soil Sampling**

One (1) grab soil sample was collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

A background sample was collected from similar lithographic soil near the wellhead by Eagle Environmental for EC, SAR, pH, boron, and ECMC Table 915-1 metals analysis. Additional backgrounds (5+) will be collected from soil of native/similar lithographic material to further compare residual arsenic, barium, and selenium, as needed.

Sixteen background samples were collected by Fremont Environmental from similar lithologies and analyzed for EC, SAR, pH, boron, and ECMC Table 915-1 metals analysis. Background concentrations exceeded the Table 915-1 standards for pH, SAR, arsenic, barium and selenium. Further, background concentrations exceeded concentrations observed in the flowline decommissioning samples.

This form serves as a timeline update to comply with the Rule 913.e. reporting schedule. Decommissioning site investigation fieldwork for the Gibson 11-9 wellhead and flowline has been completed. The Operator has requested secured lab reports for all data pertaining the the decommissioning activities conducted at this site and will conduct a thorough review of all laboratory analytical reports and data, and submit all data on a supplemental F27. The Operator will contact the ECMC Regional Environmental Protection Specialist (EPS) assigned to the project if data discrepancies are observed. Supplemental Form 27s will be prepared and submitted on a quarterly schedule to provide updates and progress of the remediation until closure criteria has been achieved.
