Comment Interim reclamation is not progressing at the location. It appears recent work has been performed at the well and soils have been disturbed and compacted. The disturbed soils need to be reseeded and stabilized until vegetation establishes with the use of BMP's (straw mulch, hydromulch, ect.). All soil decompaction, reclamation, and stabilization will need to be completed before the upcoming growing season.
