INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A compromised oil dump line resulted in 8 gallons of oil to spill to the surface and a currently unknown volume to spill to the subsurface. A vac truck was immediately dispatched to remove the surface impacts and the line was exposed and repaired.

Spill ID 486735: 54 grab confirmation soil samples were collected and submitted for TPH (C6-C36) and Organic Compounds in Soils as previously approved on Form 19 Doc #40377903. Confirmation samples were in compliance with ECOM Table 915-1.

Bonanza plans to remove 11 separators, and remove and replace the oil line between separators and tanks and the water line between separator and tanks. Bonanza plans to move to a bulk and test separator set up and move the below ground oil/water lines to above ground pipe racks. Grab confirmation soil samples will be collected from beneath the separators as well as the start/end point, change of direction, and change of material on the oil and water lines.

Source removal for the spill was completed and approximately 3000 cubic yards of soil was removed and hauled for disposal. 54 confirmation soil samples were collected and submitted for TPH (C6-C36) and Organics as previously approved on Form 19 Doc #403777903. All samples came back non-detect.

Bonanza plans to remove 11 separators, and remove and replace the oil line between separators and tanks and the water line between separator and tanks. Bonanza plans to move to a bulk and test separator set up and move the below ground oil/water lines to above ground pipe racks. Grab confirmation soil samples will be collected from beneath the separators as well as the start/end point, change of direction, and change of material on the oil and water lines.

The General Liability coverage within the Civitas Resources insurance program includes coverage for bodily injury, property damage, and pollution clean-up costs arising from qualifying pollution events of a sudden and accidental nature subject to a \$1,000,000 per occurrence limit and \$2,000,000 aggregate limit. The Civitas Resources insurance program includes Excess Liability coverage of \$110,000,000 per occurrence and in the aggregate which sits over the sudden and accidental pollution within the General Liability coverage. It is the opinion of Civitas Resources that this total tower of limit is adequate to address the costs of remediation associated with any qualifying pollution event.
