INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the WATSON 66N65W 28SWNW Tank Battery removal. Soil samples were collected from the base of the produced water vessel excavation, beneath the ground oil tank, and at the risers for the flowline and dumpline separator.

Grab confirmation soil samples were collected from the base of the produced water vessel excavation, beneath the ground oil tank, and at the risers for the flowline and dumpline separator. In addition, the on-site dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic compounds per ECMC Table 915-1 and inorganic parameters (TDS, chloride, sulfate, sodium, potassium, bicarbonate, and carbonate (as CaCO₃)).

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples were collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. A detailed summary of decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, is attached to this Form 27.

Three background soil samples were collected near the tank battery and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background soil samples were collected from depths ranging between 0-0.5 and 5 feet below ground surface (ft bgs). The maximum background concentrations with a 1.25x multiplier applied for arsenic and barium were calculated to be 7.43 mg/kg and 226 mg/kg, respectively. All arsenic and barium concentrations observed during decommissioning were below background levels.

The implementation schedule has been changed due to the decommissioning of the WATSON 66N65W 28SWNW Tank Battery and necessity for supplemental site investigation activities adjacent to the tank battery. The proposed site investigation will be completed following the approval of this form, landowner negotiations, and crew availability.

This Form 27 is being submitted to include the decommissioning results at the former WATSON 66N65W 28SWNW Tank Battery location. A proposal to delineate the pH exceedances identified during decommissioning (soil samples AST01@0-0.5', PWV01-B@5', PWV01-E@3', SEP01-DL@3', and SEP01-FL@3') is presented in the Site Investigation Report section of this Form 27.

Three background soil samples were collected near the tank battery and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background soil samples were collected from depths ranging between 3 to 10 feet below ground surface (ft bgs). The maximum background concentrations with a 1.25x multiplier applied for arsenic and barium were calculated to be 7.43 mg/kg and 226 mg/kg, respectively. All arsenic and barium concentrations observed during decommissioning were below background levels.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the pH exceedances observed during decommissioning. A proposed SSI map is attached to this Form 27. During the SSI, soil samples will be collected and analyzed for full ECMC Table 915-1 constituents. Concurrently with the SSI, additional background samples will be collected to determine if elevated pH is attributed to native soil conditions at the site.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
