Comment Interim reclamation was not conducted within 3 months of drilling or subsequent operations. There are undesirable weeds throughout the location that were not controlled. All disturbed areas including the access road must be reduced in size and reclaimed. Disturbed soils will need to be decompacted by criss ripping to at least 18 inches. The topsoil piles will need to be replaced and recontoured.
