INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared as a supplement to the approved Form 27-Initial (Doc# 403795704) which provided prior notice of the closure of the east side of the Canon 3&6-15 production facility. This form has been prepared to provide prior notice of the change in scope of work to include the removal of the west side of the Canon 3&6-15 production facility.

Decommissioning activities were completed at the entire Canon 3&6-15 facility on 8/23 and 8/28/2024. Groundwater was not encountered during excavation activities. Visual inspection and field screening of soil at four aboveground storage tanks (ASTs), four produced water vessels (PWV), one emission control device (ECD), four meter houses, two dumphine locations, and three separators were conducted removal activities, and soil samples (AST01@0.5', AST02@0.5', AST03@0.5', AST04@0.5', PWV01-B01@5', PWV01-N01@3', PWV02-B01@5', PWV02-W01@3', PWV03-B01@5', PWV03-S01@3', PWV04-B01@5', PWV04-E01@2.5', SEP01-INLET@5', SEP01-OUTLET@5', SEP02-INLET@5', SEP02-OUTLET@5', SEP03-INLET@3', & SEP03-OUTLET@3') were submitted for analysis of full list Table 915-1 constituents to determine if a release occurred. Initial laboratory analytical results indicated that total petroleum hydrocarbons (TPH), toluene, ethylbenzene, total xylenes (BTEX), 1,2,4- & 1,3,5-trimethylbenzene (TMBs), naphthalene, 1- & 2-methylnaphthalene, and/or arsenic impacts exceeding the ECMC Table 915-1 allowable levels were present at the AST02 and SEP01-INLET locations. As such, a Form 19 Spill Report (Doc# 403906705) was submitted on 8/30/2024, and the ECMC issued Spill ID 487767. A verification sample was collected at the AST02 location to confirm the initial results and final analytical results indicated that soil in that location were in compliance with the ECMC Table 915-1 allowable standards or within 1.25 times background levels for Table 915-1 metals.

Excavation activities are ongoing and will be summarized in a subsequent Form 27 Supplemental report.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Between August 23 and September 26, 2024, excavation activities were conducted to address soil impacts at the SEP01-INLET@4' location. Confirmation soil samples were collected from the base and sidewalls of the excavations at approximately 7 ft below ground surface (bgs) and 4 ft bgs, respectively. The confirmation samples were submitted for laboratory analysis of the site-specific waste profile, including BTEX, TMBs, TPH, polycyclic aromatic hydrocarbons (PAHs), and select Table 915-1 metals, using ECMC-approved methods. Laboratory analytical results indicate TMBs, naphthalene, 1- and 2-methylnaphthalene, arsenic, and barium impacts above the ECMC Table 915-1 allowable levels and site-specific background levels, remain in the separator excavation. Excavation activities are ongoing. The facility soil sample locations are depicted on Figure 1. The PID readings and soil sample results are summarized in Tables 1 and 2, respectively. The laboratory reports are attached.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

On August 23 and August 28, 2024, visual inspections and field screening of soils were conducted at the hatch, footprint, and/or loadout for each AST, three sidewall locations within each PWV excavation, at one ECD location, at four meter house locations, and two dumpline locations. Based on the inspection and screening results, hydrocarbon-impacted soils were not observed at the soil screening locations. As a result, no soil samples were submitted for laboratory analysis from these areas in accordance with the ECMC Operator Guidance for Oil & Gas Facility Closure document. A photographic log is attached.

Were background samples collected as part of this site investigation?

Two tank battery background soil sample (TB-BG01@0.5' and TB-BG02@0.5') were collected from the soil used to construct the tank battery for comparison to shallow samples collected within the fill material. Ten background soil samples were collected from the native material outside of the facility excavations. The background soil samples were submitted for laboratory analysis of pH, electrical conductivity (EC), sodium adsorption ratio (SAR), boron, and Table 915-1 metals, using ECMC-approved methods. Laboratory analytical results indicate that pH and arsenic are naturally high in the soil used to construct the tank battery and pH, arsenic, barium, and selenium are naturally high in the native soil. The background soil sample laboratory analytical results are summarized in Table 2. The background soil sample locations are depicted on Figure 1.
