This Supplemental Form 27 serves as a timeline update. SUMMIT DJ-S LLC was unable to conduct planned drilling at this site for delineation purposes on 8/14/2024 due to inclement weather and road conditions accessing the site. Summit is currently working on contracting a track-mounted hollow stem auger rig capable of achieving the 15+ foot depths and accessing the site, to complete the delineation and background sampling plan from the approved Supplemental Form 27 (Document #403875599). Delineation drilling is planned for the Spring of 2025.
