Inspection #696206128 observed that the interim areas Location are not progressing towards 1003 reclamation standards; perennial establishment is not uniform and Location is predominantly bare, or vegetated by Undesirable Plant Species. Additional revegetation efforts required. Inspection required Operator to comply with Rule 1003.b and 1002.f by 11/15/2024

Limited inspection due to snow cover, however, unable to find evidence that additional reclamation work has been performed, and BMPs to stabilize the seeded soils implemented. Additionally, no Resolution stating corrective actions have been performed or completed has been submitted by the Operator pursuant to Rule 210.b.

This CA remains applicable.

Corrective Action

CA Per Inspection #696206128:

Comply with Rule 1003.b and conduct additional reclamation efforts on the Location; Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Comply with Rule 1002.f and implement control measures to stabilize the seeded soil.
