The Spitty #1 off-location flowline will be tested prior to abandonment to represent integrity of the line. Per Rule 913.h, field screening using PID will be conducted along the flowline at areas that may have been impacted during the operational life of the flowline. Flowline samples will be collected from where the flowline connects to the wellhead and adjacent to the endpoint riser. Flowline will be abandoned in place. Form 44 (Document No. 404008590) will be submitted with the Surface Owner Waiver.
