INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the McKay AB02-13 wellhead cut and cap. Wellhead decommissioning activities and confirmation soil sampling at the McKay AB02-13 wellhead occurred on September 20, 2024. Please refer to the operator comments for additional information regarding the historical release and remedial efforts to be conducted at the wellhead. The facility and tank battery decommissioning are being conducted by Tasman and will be summarized in a subsequent Supplemental Form 27.

Approximately 93' of flowline will be removed. The COGCC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. Soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected from the area showing the highest degree of impact during field screening activities at the wellhead excavation. Soil samples were also field screened at the N-E-S-W sides of the wellhead. Following source mass removal of hydrocarbon impacted soil, confirmation soil samples will be collected from the final extents of the excavation. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Grab confirmation soil samples will be collected during flowline, facility, and tank battery decommissioning activities as outlined in Form 27 document number 403425716 and analyzed by a certified laboratory for the full extent of Table 915-1.

Visual inspection at the tank battery area will occur during abandonment activities. Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The COGCC Tank Battery and Produced Water Vessel Closure Checklists will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

Visual inspection of the flowline areas will occur during decommissioning activities. Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The ECMC Flowline Closure Checklist will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

Wellhead decommissioning activities and confirmation soil sampling at the McKay AB02-13 wellhead occurred on September 20, 2024. Laboratory analytical results indicated a historical release occurred at the McKay AB02-13 decommissioned wellhead and was reported as a historic release in Form 19 document number 403931456. Hydrocarbon impacted material at the wellhead will be removed and hauled to a permitted disposal facility. Final analytical results will be summarized in a subsequent Supplemental Form 27 submittal and will be reported along with ongoing Remediation Project Number 29870.

OPERATOR COMMENT

This Supplemental Form 27 was prepared for the historic release that was discovered at McKay AB02-13 wellhead and in connection with the initial Form 19 submitted under Document 403931456.

Source mass removal at the McKay AB02-13 Wellhead began on October 4, 2024, and analytical results are currently pending. Noble plans to conduct background soil sampling via hand auger from at least three boring locations at similar depths and soil horizons as confirmation soil samples, in areas away from oil and gas infrastructure.

Flowline, facility, and tank battery decommissioning activities will be completed by another consultant and will be summarized in a subsequent Supplemental Form 27 submittal.
