INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the HUNTSMAN G13-10 wellhead cut and cap and flowline removal. Approximately 517' of flowline was removed. The wellhead was cut and capped per ECMC rules.

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Four (4) grab confirmation soil samples were collected at the wellhead excavation (1), flowline start (1), flowline change of direction (1), and flowline terminus (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. A waste characterization sample for ECMC Table 915-1 metals was also collected. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

A site investigation will be scheduled to delineate impacted media identified at WH-FS-01@6'. Noble proposes soil samples will be collected for analysis of TPH (C6-36) and organic compounds in soil per ECMC Table 915-1. If groundwater is encountered during the assessment, each soil boring will be completed as a monitoring well and the groundwater will be sampled for BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, and inorganic parameters.

SOURCE REMOVAL SUMMARY

No source is currently generated. A site assessment was completed to delineate impacted media identified at the site. Soil samples were collected for analysis of TPH (C6-36) and organic compounds in soil per ECMC Table 915-1 in accordance with approved Form 27 Doc. # 403424958. Residual hydrocarbon impacts were not identified during the delineation assessment.

REMEDIAL SUMMARY

Five (5) soil borings were completed as monitoring wells. Groundwater samples will be collected on a quarterly basis and analyzed for BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, and inorganic parameters per ECMC Table 915-1. The inorganic parameters observed in up-gradient, unimpacted monitoring well MW-02 were used in the determination of a local background for inorganic parameters in groundwater.

NFA will be considered when groundwater is in compliance with ECMC Table 915-1 regulatory limits for four (4) consecutive quarters.
