On 12/11/2024 at approximately 12:04 hours, Compliance Inspector Dusty Popejoy conducted an on-site inspection at LARAMIE ENERGY LLC Horseshoe Canyon/2-20 Pad at Location ID #312615 in Mesa County, Colorado.

This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area.

During the inspection, the following compliance issues were observed:

1. Equipment - Gas meter building roof paneling is damaged also open hole on metal siding/wildlife hazard available for entry by wildlife with a CA date of 12/25/2024

2. Equipment - Open access to wildlife on separators/wildlife hazard available for entry by wildlife with a CA date of 12/25/2024

3. Equipment - PRV vent line does not comply with CECMC pressure safety device rules with a CA date of 12/25/2024

A follow-up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
