Laboratory analytical data indicated a historical release was discovered beneath an aboveground storage tank during the Former Moss 14-16H tank battery decommissioning. One soil sample, AST01, exceeded ECMC standards for benzo(a)anthracene at 0.0256 mg/kg.
