Open ended load line corrective action has not been completed & CA date remains 06/12/2024

Location is within High Priority/Density/Black Bear Habitat areas.

While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

1. Equipment - Multiple open ended piping/wildlife hazards/available for entry by wildlife with a CA date of 01/07/2025
2. Equipment - Open ended load line with a CA date of 06/12/2024
