A site investigation was conducted pursuant to ECMC Rule 911 at the GUTTERSEN ST T4N-R63W-S32 L01 Facility and Tank Battery location.

PROPOSED SAMPLING PLAN

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), at the risers for the flowline (s) and dumpline(s) of any separator(s). In addition, the on-site dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples were collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. A detailed summary of decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, is attached to this Form 27.

The benzene and 1-Methylnaphthalene exceedances observed at sample location (SEP01-DL@2') will be removed through a remedial excavation. Based on the benzene and 1-Methylnaphthalene (M) exceedances identified during decommissioning, Noble proposes to limit future soil sampling to BTEX, TMBs, naphthalene, TPH, 1-M, 2-M, pH, arsenic, cadmium, lead, and selenium. Concurrent with remedial excavation activities, additional background samples will be collected to determine if pH, arsenic, cadmium, lead and selenium observed at this location are indicative of native material conditions. The results of the remedial excavation will be submitted on a subsequent Form 27.

The implementation schedule has been changed due to the decommissioning of the State 64N63W 32CSW tank battery and necessity for remedial excavation activities adjacent to the tank battery. The proposed remedial excavation will be completed following the approval of this form, landowner negotiations, and crew availability

OPERATOR COMMENT

This Form 27 is being submitted to include the decommissioning results and historic reportable release discovered at the former State 64N63W 32CSW Tank Battery location. A proposal to excavate the benzene and 1-Methylnaphthalene (M) exceedances identified during decommissioning (soil sample SEP01-DL@2) is presented in the Remedial Action Plan section of this Form 27.

Based on the contaminants of concern identified during decommissioning, Noble proposes to limit future soil sampling to BTEX, naphthalene, 1,2,4-TMB, 1,3,5-TMB, TPH, 1-M, 2-M, pH, arsenic, cadmium, lead, and selenium. Concurrent with remedial excavation activities, additional background samples will be collected to determine if pH, arsenic, cadmium, lead and selenium observed at this location are indicative of native material conditions.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
