Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

Laboratory analytical data indicated a historical release was discovered at the flowline directional change during the Spike State CC30-18 flowline decommissioning. Two soil samples from the same flowline trench exceeded ECMC standards. FL01-08, and FL02-06, exceeded ECMC standards for naphthalene at 0.015 mg/kg, benzo(a)anthracene at 0.115 mg/kg and 0.0161 mg/kg, 1-methylnaphthalene at 0.0074 mg/kg. This location lies within the Pronghorn Winter Concentration High Priority Habitat. A supplemental Form 27 has been submitted for remediation project number 26849 detailing the remedial site plan, document number: 403956108.
