INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the HERBST 01-22-04-64 wellhead cut and cap and flowline removal. Approximately 565' of flowline was removed. The wellhead was cut and capped per ECMC rules.

Three (3) grab soil samples were collected at the wellhead excavation (1), and flowline terminuses at the wellhead (1) and separator (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Reclamation will be in accordance with ECMC 1000 Series Rules. Given the compliant analytical results from the wellhead assessment and in the absence of organic and other inorganic impacts, the elevated pH value at the flowline terminus appears to be de minimis in magnitude and is not indicative of an E&P release. Based upon the depth and level of soil suitability impacts, the risk to vegetation is likely negligible. Based upon this and the use of inspections to monitor future growth, no additional assessment or remediation appears necessary.
