Final laboratory analytical data indicated a historical release was discovered beneath the aboveground storage tank during the Roach Bass T5N-R67W-S14 L01 Loc tank battery decommissioning. One soil sample, AST06, exceeded ECMC standards for 1,3,5-trimethylbenzene at 0.037 mg/kg, 1-methylnaphthalene at 0.0662 mg/kg, and 2-methylnaphthalene at 0.12 mg/kg. This sample is located at the northern most AST. A supplemental Form 27 has been submitted for remediation project number 37199 detailing the remedial site plan, document number: 403976496.
