INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the BRUNTZ G16-23 wellhead cut and cap and flowline removal. Approximately 1056' of flowline was fully removed. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples will be field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection of the wellhead and flowline areas occurred during decommissioning activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. A detailed summary of decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, is attached to ECMC Document # 403848708.

Two background soil samples were collected from one discrete location near the flowline (BKG01) and analyzed for pH, EC, SAR, boron and metals in soil per ECMC Table 915-1. Background soil samples were collected from the depths of one feet and two feet below ground surface (ft bgs). Arsenic and selenium concentrations in background samples were observed to be above ECMC Table 915-1 standards.

The organic compound exceedances observed at sample locations FL01R-W, FL01-01, FL01-02, FL01-03, and FL01-06 will be removed through a remedial excavation in accordance with the proposed excavation map attached to the approved ECMC Form 27 Document #403848708. Soil samples collected during remedial excavation activities will be analyzed for the full Table 915-1 suite. Concurrently, background soil samples will be collected to determine if pH, SAR, EC, arsenic, and cadmium are attributed to native soil conditions at the site. The proposed soil boring locations are illustrated on Figure 1.

The excavation and SSI are tentatively scheduled to take place on January 6, 2024 and the results of which will be submitted on a subsequent Form 27.

Concurrently, background soil samples will be collected to determine if pH, SAR, EC, arsenic, and cadmium are attributed to native soil conditions at the site. A proposed soil boring map is attached to this Form 27.

The remedial excavation and SSI are tentatively scheduled to take place on January 6, 2025, and the results will be submitted on a subsequent Form 27.

Quarterly reporting will be conducted until closure criteria are achieved.
