A site investigation will be conducted pursuant to ECMC Rule 911 at the NATL HOG FARMS 70 RANCH T5N-R63W-S21 L02 Facility and Tank Battery location. Noble will conduct field screening during dumphine removal (separators to tank battery) and include field screening results, along with photo documentation, on Form 27 Supplemental.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Five background samples will be collected from an area not impacted by oil and gas development at similar depths (0.5' and 3') and lithologies as confirmation samples collected at the location and analyzed for ECMC Table 915-1 metals and soil suitability for reclamation standards (pH, EC, SAR, and Boron). The samples will be used to characterize native soil and potentially attribute elevated metals and inorganics concentrations, observed in the tank battery soil confirmation samples, to native soil conditions.
